Therapeutic early childhood education

Children develop healthy socialemotional, physical, and cognitive skills–all related to Kindergarten readiness and successful educational and social outcomes.


Family support and home visiting

Southside Family Nurturing Center pioneered dual-generation, holistic family services.


- Bi-weekly home visiting (offered virtually during the pandemic)

- Community gardening




In 2019, we served 231 family members.

RELEVANT

- One of the first private, nonprofit agencies in MN to implement holistic family interventions, SSFNC celebrated 45 years of service in the Philips Community.
- Thanks to an Arts Activity Support grant from the Metropolitan Regional Arts Council, SSFNC children, families, and staff learned from Latinx, African, and Native American artists in our Drumming and Dancing Across Cultures series.
- SSFNC received funding to expand home visiting services and implement the evidence based, culturally responsive Family Spirit Home Visiting Model.

ACCESSIBLE

 Successful fundraiser afforded SSFNC the purchase of 2 buses, essential for getting children between home and our early childhood education program.

responsive

- Quickly switched our in-person model to virtual learning and home visiting. Supported connection and learning through materials delivery and virtual individual and therapy sessions.
- SSFNC delivered weekly groceries, paper, and cleaning supplies to 35 families due in part to a \$20,000 CARES Act Food Support grant from Hennepin County.
- Children enrolled in SSFNC early childhood education program received a computer tablet and technical assistance to ensure continued learning and developmental progress during COVID closures.
- SSFNC and Wayside Recovery Center partnered to deliver virtual education and age-appropriate activities to children residing with their mothers at Wayside.

2020 (Continued)

 In community with Barbara and Francis Bettleyoun, SSFNC stepped into a Healing Gardening project with families, nurturing therapeutic connections with each other and with Mother Earth. Garden visits allowed families to safely meet with home visitors during COVID and community unrest.

Equity-focused

- SSFNC launched We Rise: Breaking Cycles, Building Equity awareness campaign to enhance people's understanding of the Phillips Community and invite new partnerships in communities with similar needs that may benefit from SSFNC's holistic, dualgeneration model.
- SSFNC Teacher/Home Visitor Team authored a trauma-informed booklet for teachers and parents to use as a tool for talking about children's feelings about our community and the death of George Floyd.

Breaking Cycles – Building Equity

In July of 2020, we launched **We Rise**, an awareness campaign elevating Southside's collective work, nurturing children, building on family strengths, and finding alternatives to violence. Sitting in the heart of South Minneapolis, **We Rise**, **Breaking Cycles – Building Equity** speaks to the lived experience and challenges of children and families most impacted by present and historical violence, injustice, and racial inequity.





Food Insecurity among SSFNC Families

From March 2020 to Dec 2020, SSFNC consistently delivered 3 bags of groceries to an average of 35 families/week for a total of 30 weekly deliveries.

Thank you, la escuelita

I met with Juana for our weekly home visit. She said, "Tell everyone thank you for the food! Right now we are not working, laid off from the restaurant due to the pandemic. I'm so thankful to 'la escuelita' (the little school) for helping us in this difficult time. I know that my children won't have to suffer like I did when I was young." Quiet and teary eyed, Juana recalled her childhood, walking in the rain looking for firewood for cooking. Juana's mother passed away when Juana was only thirteen. It was then that Juana stepped into the role of caring for her two younger brothers. They only ate rice and occasionally milk. She continued, "I am grateful because it can be worse. Thank you."

Families, like Juana's, overcome immense obstacles and are incredibly resilient. We know that investing resources at SSFNC contributes to families' sense of community and long-term family stability. Juana and other families are nurturing strong futures for their children despite the additional stress and trauma that they have experienced this past year.

Gaining Self-Regulation and Self-Efficacy

Noah struggles with auditory sensitivity and is easily distracted and distressed by sounds. This really impacted his ability to participate at school, as he would often stop engaging when overstimulated or overwhelmed. In Occupational Therapy, we worked on noticing and naming sounds, talking about how it felt to hear them, but then returning to the activity we were engaged in. Now when a sound surprises him, Noah can tell us what he heard and resume his activity on his own. He has made a lot of progress in trying new things, expressing himself, and standing up for himself when he is uncomfortable in his environment. Instead of shutting down, Noah's able to self-regulate by using the strategies he's learned in therapy. We are so proud of him!
